SECTION 4: FIRST AID MEASURES

4.1 Description of first aid measures:

SECTION 5: FIREFIGHTING MEASURES

5.1 Extinguishing media:

Product is non-flammable under normal conditions of storage, handling and use. 5.3 Advice for firefighters:




